

WHAT YOU SHOULD DO

- Before you sign this form, read the information on our website at www.eclegal.com.au under Motor Vehicle Disputes. Contact us if you have any
- Complete the details on this form fully and truthfully. Provide as much information as possible;
- Sign and return the form to us. Our address is on the first page; 3.
- Be prepared to provide us with a copy of the vehicle registration certificate and any other information about the collision If you are comprehensively insured, lodge a claim form with your insurer marked "Report Only". This will protect your rights & should not affect your no claim bonus if a claim is not made;
- Refer any communications from the offending party or their insurers to us. Do not communicate directly with these people.

WHAT WE WILL DO

- Ensure that your vehicle is assessed by qualified assessors. There is no need for you to obtain any further quotes;
- Make a claim on the offending party or their insurers. Upon recovery of funds, we will pay your service providers directly (i.e. repairer, hire car company);
- All costs and charges will be paid by the offending party or their insurance company. The repairer or hire provider will also contribute to these costs and charges. There will be no cost to you except in circumstances where your vehicle is written off, liability for the collision is denied, the offending party is not covered by insurance, you deal directly with the offending party or their insurance company, withdraw your claim after 14 days of us contacting you to confirm these instructions or decide not to authorise the repairer to repair the vehicle.
